- ✓ **All completed forms**
- ✓ **A one hundred (100) word synopsis**
- ✓ **Entry fee**

1. The official entry form must be completed in its entirety or the entrant will be disqualified.
2. Entry fees will not be returned if entrant is disqualified or does not end up participating in the Frenzy.
3. All entries must be uploaded to www.rentonfilmfrenzy.com by 7:00 pm Sunday, October 10, online in a QuickTime file, or contact info@rentonfilmfrenzy.com to make special arrangements. In addition, all entries must be submitted on DVD, with two copies, to the Frenzy Information Booth between 2 and 7 p.m. on Sunday, October 10.
4. There is a \$50 entry fee for the Open Division and \$25 entry fee for student competitors. (Sorry, we cannot refund entry fees). ***All team members in the Student Category must be 18 and younger.***
5. Acknowledgement of each submission will be sent via e-mail.
6. Short film entries must be no longer than 4 minutes from the start of the film to the end of the credits. Any film longer than the prescribed time will be disqualified.
7. Collaborative work is accepted. One of the partners should be selected as the primary contact.

8. Entry must be the original, and un-produced, un-optioned work of the entrant(s). The entrant(s) ensures that he or she (they) is (are) the sole creator of the work and that it does not infringe on any existing copyright.
9. Any music that is used must be original or royalty free. No copyrighted music will be allowed unless proper permission has been granted.
10. All entrants shall retain the rights to their submitted film.
11. Entrants are prohibited from contacting the judges during the competition.
12. Any entrant who attempts to contact a judge will be disqualified. All decisions of the judges are final.
13. Entries must be suitable for all audiences.
14. The City of Renton, Renton Film Festival and Renton FilmFrenzy accept no liability whatsoever for any claims of damages, real or perceived, by any entrant(s) as a result of their participation in this contest.
15. All winners are responsible for their own federal and state income tax withholding.
16. Employees and staff of the City of Renton and all of the other Renton FilmFrenzy sponsors are eligible to participate, however, members of the FilmFrenzy planning committee are not eligible.
17. Entering the competition constitutes permission to use the entrant's names and likenesses for publicity and promotions with no additional compensation. The City of Renton reserves the right to publicize and promote any and all progress, development and success of the entered short films.
18. All decisions on winners and finalists are final.
19. FilmFrenzy organizers reserve the right to change make changes to the Frenzy, the awards ceremony and other components. Frenzy participants shall be notified via e-mail of any changes.
20. Multiple entries are accepted, provided that each film is entered separately with all entry requirements stated in #1.
